**RULES:**

1. Entrant MUST be a FEMALE USBC and California Women's 500 Club member in good standing and present her membership card prior to bowling. Duplicate California Women's 500 Club cards are available for purchase (\$2). Membership will be verified
2. Entering Average:
  - A. The HIGHEST 2013-2014 BOOK AVERAGE, (SUMMER OR WINTER) posted on bowl.com of 21 games or more (SEE RULE 118C; HIGHEST AVERAGE PER USBC PLAYING RULES)
  - B. If none, then use highest current average of 21 or more games as of January 1, 2015. All others excluded. Rules 319-A/319-C will apply. Rules 319-B, D and E will not apply. The bowler must provide a standing sheet with her current average of January 1, 2015 (bowler is responsible to verify the accuracy of her average). If current average is 10 pins higher than 2014 book average she must disclose the higher average. If not disclosed, the entry will be disqualified.
  - C. USBC rules prevail and anything not covered above will be decided by The CA Women's State 500 Club Tournament Committee.
3. Tournament entries close with the last CAUSBC team event. Tournament is USBC Certified.
4. Prize fund 100%, one cash award for every five (5) entries or major fraction thereof in each division. Duplicate prizes for ties. Bowlers may cash only once.
5. **BOWL STATE 500 ANNUAL CHAMPIONSHIP TOURNAMENT AT CAUSBC TEAM EVENT.** Entrant will use her team event score as her 500 Singles score plus handicap. ENTRY FEE must be paid prior to bowling your CAUSBC team event.
